

OFFICIAL BOARD ANNUAL REPORT

Gower Street United Church has had another busy year with plenty to keep us on our toes. In the Spring, everyone was sad to learn that The Reverend Dr. Kate Crawford had been called by First St Andrew's United Church, London, Ontario and after much thought had decided to accept this Call. This change in the pastoral relationship required that Gower carry out a Joint Needs Assessment and we were fortunate that the group responsible for the 2009 Joint Needs Assessment report were prepared to step up to the plate and using much of the knowledge that they had acquired in 2009 repeat the process and produce a new report in June. When the 2010 JNA Report was approved by the congregation at a Special Meeting on June 26, 2010, the congregation also elected people to serve on the Joint Search Committee and this Committee worked diligently producing our advertisement, asking for recommendations of suitable ministers for the position at Gower, and talking to recommended ministers to suggest that they apply.

Meanwhile we have been fortunate to have the Rev. Marion Davis working full-time for us since the Rev. Kate left, and to have the very able assistance of the Rev. Miriam Bowlby from September to the end of December. Rev. Marion submitted her resignation as of June 30, 2011, and the Rev. Miriam left to take up a full-time position at Cochrane Street at the end of this year. This is a challenging time in the life of Gower and should be held in our prayers.

First I would like to thank all those who contributed to Gower's outreach activities this year. Outreach service to the community is an important part of Gower's mission. Monthly services are organized and led at Cambridge Estates by the Men's Club, at Elizabeth Towers by the U.C.W. and at Hoyles Home by a group organized by the Rev. Marion Davis. Also, the Gower Community Band provided much enjoyment as it went throughout the community bringing music and happiness to seniors and others. The Seniors Club supported by the Men's Club continued to provide a meal and entertainment for seniors from across the city. The Outreach Committee held two successful evening gatherings for New Canadians and the U.C.W. provided Pottle Centre members with a Christmas Dinner. Another outreach activity involved Street Reach on Wednesday lunchtime as they use our Lecture Hall and kitchens to provide a cooked lunch for those in need. We also provide For the Love of Learning with the use of the gym for a token rent. These activities, and some I may have missed, along with our support for the Stella Burry Corporation, Bridges to Hope, and the Mission and Service Fund are important outreach activities and signs of Gower's answer to the call that Jesus Christ gave to his disciples. In addition, our ministers also provided much outreach and benevolent assistance to the community that we never hear about: activity that included looking after folk who come to Gower's office with a wide variety of problems.

I would also like to thank all those who contributed to the fundraising activities this year, the Men's Club which undertook to fund restoration projects, the U.C.W. who contributed money to the Operating Fund, and committees such as the Stewardship Committee and the Organ Fund Committee that worked to raise money for Gower. In addition we should thank all those of the Gower family who through P.A.R., or envelopes, or the loose collection donated regularly to Gower.

Thank all of you who have served Gower, through its Board and committees, and have given of your time and talents in ways too numerous to list here. The work of Gower could not go ahead successfully without you.

A particular thank you must go to all our staff:

- those who provide us with superb music, Carl Goulding, Dr. Doug Dunsmore and Edsel Bonnell;
- David Noseworthy and Linda Hogan whose work load has increased over the year due in part to our successful rental program and to other activities,
- and to our ministers: the Rev. Dr. Kate Crawford, the Rev. Marion Davis, and the Rev. Miriam Bowlby.

Thank you one and all. May God bless us with the wisdom, conviction and opportunity to serve as Jesus asked us to serve in the years ahead.

A Prayer for Reading the Annual Report



REPORT FROM THE MINISTER

REV. MARION DAVIS



Church annual reports tend to be written in the Season of Light – Epiphany. We appreciate the brightness of each sunny day and, whatever the weather, we notice that the mornings are not quite as dark and that the light lingers longer into the evening. It's the time of year when we appreciate every source of light that we can find. As I review the year 2010, there are many sources of light. Here are some which stand out for me:

- The continuation of a conversation with the other downtown churches, initiated by East District and the combining of George St. and Gower congregations, once in each church on July 25 and August 8;
- New members to our congregation;
- Kate's leaving to accept a call to London, Ontario was light, tinged with darkness. While I am thankful that Kate was with us for five years and celebrate with her the challenge and excitement of this new ministry, I miss her and her daughters, Martha and Norah.
- The dedication and spiritedness of the Search Committee;
- The presence of the Rev. Miriam Bowlby, during the fall much appreciated;
- Our Fall Celebration in Pippy Park with Sunday School members and their families;
- A Worship Leaders' Workshop in October;
- Our outreach to those in our neighbourhood who come to the church office and For the Love of Learning who share life with us in our building;

TRUSTEES



The primary responsibility of the Trustee is the control and administration of the Real and Personal property held in Trust for the benefit of the Congregation. These Properties include all church buildings, furniture and other related assets included in the Endowment and Manse Funds.

During 2010 the Insurance Committee reviewed our Insurance Policy relative to our Property and Liability coverage. They were also involved in our property damage claim resulting from the hurricane and rain storm during September.

The Stock Market decline in 2008 had a significant effect on the Market Value of our Endowment and Manse Funds in that they lost approximately 9% of their value. During 2009 and 2010 the Market had a slow steady recovery with the result that the Market Value of our Funds is now only ½ of 1% or \$4300.00 below their Book Value. Continued recovery of the Market is anticipated.

GENERAL PROTESTANT CEMETERY COMMITTEE



The General Protestant Cemetery Committee has experienced a successful year, having operated both cemeteries and still having a small credit balance at year end. This means that the funds collected for burials was sufficient to cover off the operation and maintenance of both cemeteries.

There have been very few capital works projects done this past year as we are moving to our new cemetery in less than two years. At that time we will have to borrow a substantial amount of money to prepare the cemetery for use. In order to make annual payments on our loan we will require additional funds. To accommodate this, it was decided at our annual meeting that each church representative remind their church of the regulation stating that an amount of five dollars per Church paying member be given annually to the cemetery fund. While this is currently being paid by some of the nineteen churches, there are others who have paid only a portion and still others who have paid nothing. Since we have no other way of raising additional funds to cover the loan the Committee is hoping all of the Churches will meet their obligations in the future.

The Committee experienced a successful operating year in 2010. The two annual flower services cost less than previous years but were still considered successful. There were no Major expenses such as a breakdown of equipment etc. or any other unexpected expenses.

There were a total of 244 burials of which 95 were cremations.

In the coming year a columbarium will be established in Mount Pleasant cemetery for cremation burials. Also in 2011, some major work will be done on 'Memorial Gardens' cemetery consisting of building a new road, clearing and seeding 10 acres of land, fencing, and putting in drainage. The two flower services in 2011 will be held at Mount Pleasant Cemetery on July 4th and at the General Protestant Cemetery on July 25th.

REPORT FROM THE EAST DISTRICT REPRESENTATIVE



On May 28 - 30, 2010, the Spring East District Meeting, Newfoundland and Labrador Conference was held at Burry Heights Camp and Retreat Centre.

The theme of the meeting was "All Things New." There are many new changes happening in our churches in Newfoundland and Labrador such as amalgamation of churches, declining members of our congregations, and added responsibility put on lay ministry to carry on the spiritual and outreach mandates of our church.

One of the highlights of the meeting was the Milestones in Ministry Banquet that was held on the evening of May 29th. The banquet was held to thank and recognize the ministers who were retiring and celebrated anniversaries in Newfoundland and Labrador. This year The Rev. Lewis E. Crewe, The Rev. John R. Davis, Ms. Lorraine E. Moores, DLM, The Rev. Lisa Potter and The Rev. Russell L. Small retired as ministers in the Newfoundland and Labrador Conference.

On October 15 - 17, 2010, the Fall East District Meeting, Newfoundland and Labrador Conference was held at Burry Heights Camp and Retreat Centre.

The theme of the Meeting was "Seek, Look, Become." The guest speaker at the fall meeting was Rev. Bruce Sanguin, Minister at Canadian Memorial United Church in Vancouver, British Columbia and author of "The Emerging Church." He shared his experience of change at Canadian Memorial United Church and in his address he outlined some ways to bring about change in congregations. His presentation inspired lots of discussion and gave the delegates attending the meeting new ways of looking at our church.

MINISTRY & PERSONNEL



2010 was certainly an active year for the M&P Committee. We endeavoured to continue to provide the required support and guidance to all staff and at the same time putting measures in place to ensure that with the departure of Rev. Dr. Kate Crawford that adequate ministerial support to the congregation would continue. Upon receiving notification of Rev. Kate's departure we immediately asked Rev. Marion to move up to full time as of July 1 and we started looking for an interim supply Minister to assist Rev. Marion for the interim period, on a part time basis, until a new minister is called. We were successful and on August 23, 2010, Rev. Miriam Bowlby started with us focusing primarily on pastoral care and worship leadership. Unfortunately for us, but certainly fortunately for Rev. Miriam, she received a call to a fulltime ministry position at Cochrane Street United commencing January 2011. Based upon a number of factors including the fact we hope to have a full time minister called by July, Rev. Marion's willingness to take on the full responsibility and that a number of lay and ordained members of the congregation have stepped forward to assist, we have decided not to seek out another supply Minister.

Just prior to her departure the M&P Committee conducted an exit interview with Rev. Kate to gain some insight and recommendations to help us through the transition and beyond. When asked what her final words of advice or encouragement would be for the Congregation she replied "continue to be disciples of Jesus Christ and we will NOT fail!"

Throughout the year our regular staff continually went beyond the call of duty to ensure that things went as smoothly as possible. The Choir under the Leadership of Dr. Doug Dunsmore and Organist Carl Goulding continued to provide inspiration to us all. Doug has also taken an increased role in service leadership and thereby providing somewhat of an anchor as we have different people leading service throughout this time of transition. The Gower Community Band under the leadership of Edsel Bonnell continued to provide an opportunity for the musically inclined members of our congregation and the community at large to perform and contribute to services during the year and entertain many audiences throughout the City.

Our Office Manager Linda Hogan and Custodian, David Noseworthy, continue to provide yeoman service as we moved through this past year. With the increased activity in the church including the many Rentals of facilities there has been increased demands on both Dave and Linda to deal with the associated administration activities as well as the set up before and the clean up after. But somehow Dave and Linda seem to pull it off. Having said that this is an area we need to look at to provide them with additional support in the future.

WORSHIP & SACRAMENTS

Mandate

The mandate of the Worship and Sacraments Committee includes providing for regular and special worship services, the administration of the sacraments, developing policy with respect to the admission, transfer and removal of membership. The Committee has the responsibility to advise ministry personnel

and the Board on the use of the church sanctuary.

Worship Services

The aim in worship is to point to the One whom we serve as we gather with a sense of belonging to God and to each other. Our worship services in 2010 included the *Jesus at the Movies* series during Lent; sermons in the *Illumine* series which focus on the stained glass windows in our sanctuary; the playing of rhythm instruments by our Sunday school during a hymn at the beginning of the service.

A very special worship service was held on Sunday Nov. 21st celebrating the 195th Anniversary of Gower St. Church. At that time we were fortunate to have a former minister and now member of Gower, The Rev. Dr. George LeDrew, preach the sermon. The recently renewed Children's Choir, the Senior Choir and the Gower Community Band added much joy and inspiration to the celebration.

Gower St. Church and good music are synonymous. We give thanks for the vital role of music in our worship services. We thank the Senior Choir, Dr. Doug Dunsmore, Grace Dunsmore and Carl Goulding for their faithful, weekly presence in leading and carrying us through each service. The Children's Choir directed by Dana Abbott Collins is a delight whenever they sing for us. Thanks to the Gower Community and Edsel Bonnell for their enduring presence which continues to be an important part of the music at Gower.

The five-year stay of The Rev. Dr. Kate Crawford among us came to an end June 30th when Kate accepted a call to First St. Andrews United Church. We were blessed with Kate's gifts for ministry and her leadership in worship since 2005. While we wished she could have stayed longer with us, we willingly gave our blessing and good wishes for her new pastorate. In September we welcomed the Rev. Miriam Bowlby who was with us in a half-time position until the end of December when she left to become the full-time minister of Cochrane St. United Church.

Sacraments

- Holy Communion was celebrated six times during the year. It was decided at the April 27th meeting to continue serving communion by intinction with stations at the front of the church.
- Baptism was celebrated on a regular basis.

Accessibility

- Through a generous donation we now offer hearing devices for use during worship services so that those who are hearing impaired have a better opportunity to participate fully in the time of worship. The response to these devices has been gratifyingly favourable. We provide the printed text of the sermon each week for those who request it as well as large print bulletins for those visually impaired.
- Sermons and bulletins are on the website and are viewed or listened to weekly. These are much appreciated.

It is with the help of many others that the Worship and Sacraments Committee lives out its responsibility as mandated in the Constitution. We thank:

- The Men's Club, Outreach Committee, for conducting worship services when ministry personnel were away;
- All who have given leadership in worship through reading scripture and offering the Prayers of the People;
- Children who have participated in lighting the Christ candle;
- The Sunday School for its part in the White Gift service and the play they presented with direction of Carolyn Moore, Sunday School coordinator, and all the teachers and leaders of the Sunday School; the Outreach Committee for organizing and distributing the gifts given at the White Gift service;
- All who have prepared the elements, set up for communion, and then done the cleanup following the service, including after midnight on Christmas Eve;
- Ken Butt and Andy Fisher for maintaining our website, ensuring that the bulletins and sermons are available on the internet.
- Linda Hogan, office manager, and David Noseworthy, caretaker, for all the ways in which they offer support.

GOWER BAND PROGRAM

The Gower Community Band continued to excel in quality of performance and service to community as a non-denominational outreach program of Gower Street United Church during 2010. The Band performed on a total of 17 occasions during the year, including the Feb. 14 Memorial Hymn Sing, the Mar. 28 Palm Sunday Musicale and service, the Nov. 21 celebration of the congregation's 195th

Anniversary, and the Dec. 19 Christmas Musicale and service at Gower; the GCB annual "Terra Nova" scholarship concert for young composers at MUN Music; the 2010 "Festival of Remembrance" for Newfoundland and Labrador veterans held at the Basilica of St. John the Baptist on Nov. 7; the treasured traditional annual Christmas Tree Lighting at Masonic Park on Dec. 1 and the Shiners' Carol Service and Concert on Dec. 19; and seniors' shows at the Veterans' Pavilion of the Miller Centre (2), Meadow Creek Retirement Home in Topsail, St. Patrick's Mercy Home, Glenbrook Lodge (2), Cambridge Estates, Hoyles' Home, and Escasoni. The Band was honoured to be cited in Memorial University's Strategic Plan as a potential research partner of the MUN School of Music in composition and conducting. During the past three years, 15 exciting and innovative works have been created by young composers in the GCB's "Terra Nova" scholarship competition, and successful entrants have had the opportunity to work with the band in a dynamic interface to further develop and "fine-tune" their compositions. Meanwhile, the GCB continues to attract and welcome new members in a vibrant intergenerational musical community ranging in age from 10 to 76.

Finances: Income amounted to \$9,492.01, comprised of \$6,445 in donations, \$2,045 in revenue from concerts and sales, and \$602.01 in members' funds and bank interest, and \$400 interest from the Gladys L. Roberts Memorial Scholarship Endowment. Expenditure amounted to \$8,243.88, comprised of \$3,652.07 in Music, Equipment & Instrument Maintenance, \$2,562.34 in Performance Expenses, \$1,156.50 in Scholarships & Training(*), and \$872.97 in Operating Expenses. This resulted in an operating surplus of \$1,248.13 for 2010, which was added to \$2,990.03 brought forward from 2009 for a total surplus of \$4,238.16 to be brought forward to the 2011 Operating Fund. (*It should be noted that the current account expenditure on Scholarships and Training does not include the annual award of the Gower Youth Band Entrance Scholarship of \$1,000 at Memorial University's School of Music, which has been fully endowed and will continue in perpetuity without requiring further contributions). The surplus will allow the Band to implement its commitment to increased scholarship and training in 2011. There were no capital expenditures from the Instrument & Equipment Reserve Fund in 2010.

Appreciation: The mission and ministry of the Gower Community Band, the inheritor of the 38-year-old tradition of the nationally-recognized Gower Band Program, was founded and is firmly rooted in community service. Members of the GCB are dedicated to, and inspired by, the Band's commitment to music scholarship, development and maintenance of individual skills, creativity in composition, and service through music in its performances for church and civic events and especially in its focus on the growing Senior Citizens sector with "concerts for people who can't get out to concerts". As we have acknowledged over the years, none of this would be possible without the support of friends and benefactors at Gower and in the wider community. We can only offer sincere thanks to the Ministers, Official Board, staff, and congregation of Gower Street United Church for the vision, support, commitment, and friendship which has created and maintained this unique gift to community over 38 years. ORGAN RESTORATION FUND COMMITTEE



2010 was a year of continued progress in our campaign to finance the restoration of Gower's historic Casavant Pipe Organ, Opus 1386. During the year we received cash donations of some \$61,700. These gifts, combined with the donations and tax recoveries of prior years result in total contributions of approximately \$310,000 since the campaign was launched in November of 2007. In addition, we have commitments totaling \$19,000 to be received over the next two years. This brings the overall total of donations and commitments to date, to \$329,000.

In September, we confronted an unexpected challenge when the organ was damaged by water as a result of storm damage sustained to the Church building by hurricane Igor. The damage to the organ has since been repaired by the organ manufacturer, Casavant. Apart from the deductable of \$5,000, the organ repair costs were essentially covered by insurance. In the course of the repair, steps were taken to the extent possible, to protect the organ against the potential for further damage of this nature. In addition, the larger question of necessary remedial measures to enable the Church building to withstand severe storm pressures is being addressed by the Property Committee. Most significantly perhaps after the events of last fall, Carl Goulding assures us the organ is again functioning "as good as new" - a fact that is clearly reinforced each Sunday with Carl's organ postludes.

As of December 31, 2010, after meeting our interest obligations as well as the initial funding of the hurricane damage costs, the principal on the organ restoration loan had been reduced to \$244,432. In due course, the recovery of the majority of the hurricane costs under our insurance policy will provide for a further principal payment which will reduce the loan to less than \$230,000. Clearly we have come a long way since 2007 when the congregation approved the organ restoration project at a capital cost of \$500,000.

In many respects, our success to date is attributable to the ongoing support of the Gower Congregation. This comes to us both in the form of regular direct donations, special donations in memory of family and friends, as well as continuing support for, and attendance at, various functions and activities sponsored by; the Men's Club, the UCW, the Choir, the Band, the MUN Festival and Chamber Choirs, the Philharmonic Choir of the NSO and of course the Art Exhibitions and Sales by Carl Stevenson. We also reiterate that the unwavering leadership and dedication of Gower's musical triumvirate of Doug Dunsmore, Carl Goulding and Edsel Bonnell have proven to be invaluable to us.

There is also an important additional dimension to be emphasized. Our progress is also due in no small measure to the support of the broader community – to the various other "friends of Gower", to the foundations, to the charitable funds, to various members of the music community, and to the organizations and individuals previously highlighted over the last three years. More recently, we had a prime example in December – "The Once" graciously turned their most successful concerts at Gower into a gesture of financial support for the Organ Restoration Campaign. These gestures, individually and collectively are all so important and so greatly appreciated.

We express our sincerest appreciation to every individual, group and organization that has supported the Organ Restoration Campaign to this point. We are also very gratified to learn that we may expect further initiatives in the months ahead.

We are more than half way there! As we continue the campaign in 2011, we invite and welcome your ongoing support to help us achieve our most worthy objective.

HERITAGE AND ARCHIVES

On May 18, the Committee sponsored a lecture by Calvin Hollett, based on his recently published and well-received book, "Shouting, Embracing, and Dancing with Ecstasy: The Growth of Methodism in Newfoundland, 1774-1874." This was a follow-up from the lecture Dr. Hollett had given at Gower last year.

On June 6, the Committee sponsored in the Lecture Hall a session entitled "Growing Up at Gower". A panel of Gower members recalled their memories of being children at the church, as did a number of the audience in the 'open mike' phase of the session.

As well, numbers of donations of items related to Gower were gratefully received and processed. STEWARDSHIP COMMITTEE



2010 was the 195th Anniversary of our congregation and your Stewardship Committee had a busy year as we led in arranging the celebrations.

This was our main focus in 2010 as we felt highlighting our past would bring a greater awareness of the contributions made by past members and would hopefully bring a new spirit to us all which we hope would reflect in increased revenue.

It was important that all members be kept informed about church activities and throughout the year we had Pulpit speakers bringing us "seconds for stewardship" with emphasis on youth and adult groups and PAR (pre-authorized remittance).

In May we held another 8 Track Favourites Concert and though it wasn't as successful as the previous year, we did break even. Even though we didn't generate any profit on the venture, we did raise awareness of Gower as a good concert venue and it should auger well for the future.

On Sunday November 21st we had a successful Anniversary service with the President of Conference as our Guest Preacher. We plan to host a 195th Anniversary Dinner in January 2011.

In December your committee assisted with the "The Once" concert as we provided and sold ginger cookies, cider and hot chocolate during intermission and realized over \$1,000 for our Operating Fund. I would like to thank all who helped with this venture and to those who assisted us during the year a Big Thank you.

During 2011 your committee will work hard to make our congregation more aware of electronic remittance through PAR and its benefits to the giver and receiver. MEETINGS OF THE DOWNTOWN CHURCHES



A year or so ago East District set up a joint committee consisting of a number of East District members and members of the four downtown churches to talk about their visions for the future and how the four downtown churches could work more closely together.

So far there have been eight meetings led by the Rev. Roger Janes of the Newfoundland and Labrador Conference. The first four meetings were of an educational nature around visioning and collaboration. More recently the meetings have moved on to discuss practical ways in which the churches can collaborate and get to know each other better.

A whole range of possibilities were discussed:

- looking for bulk-buying opportunities;
- having joint groups: perhaps a joint youth group or young families group;
- joint services where one church arranges the service which is then attended by all four congregations;
- having the four Board Chairs meet regularly together so that they are aware of what is happening at the other churches;
- having a central place where members can go to find out what fundraising events are planned by each church and when they are happening;
- having the four churches enter an arrangement to become a four point pastoral charge,
- considering combining the four churches into one congregation;
- building a new more energy efficient church downtown;
- having conference take out an option on a suitable piece of land.

This group has no real authority. Anything that the downtown church group decides might be good, will be taken back to the Boards of each church before any action will be taken. Reports of the meetings go to the East District Executive.

These meetings are open to members of the four churches and so far 4-5 Gower members have attended each meeting, although who attends from Gower changes somewhat at each meeting. 1. Welcome and Opening Prayer

David Roberts, Chair of the Official Board opened the meeting and welcomed those present. He thanked Board members and members of the congregation who brought along cookies and sandwiches and helped with the setting up and serving of lunch. Then he led us with a prayer. About 70 members of the congregation were in attendance.

2. Appointment of the Chair and Secretary for the Meeting

3. Adoption of Agenda

4. Approval of Minutes

The minutes of the last Annual Congregational Meeting held March 8, 2009 were moved for acceptance by Linda Hogan and seconded by Jim Churchill. Approved.

5. Message from the Chair of the Official Board

The Chair, David Roberts referenced his report on pages 4-5 in the 2009 Annual Report. From a financial point of view it has been a very rewarding year; the Finance Committee had budgeted a deficit for Operations, but the Income Statement for Operations shows a surplus. The financial goal for Mission and Service was exceeded and the Organ Restoration Fund has reached the halfway mark.

David expressed sincere thanks to the dedicated staff who worked so hard in 2009: Linda Hogan, office manager; David Noseworthy, caretaker; Carl Goulding, organist; Doug Dunsmore, choir director; Edsel Bonnell, band director; and Rev. Dr. Kate Crawford and Rev. Marion Davis, ministers Mr. Bonnell sent his regrets; Jill Howlett, band manager represented the Gower Band. David also extended thanks to the many volunteers who helped in so many ways; especially the Committee Chairs and members, the Men's Club and UCW.

The Chair, stepping down after four years of service, concluded that it has been challenging yet rewarding. He extended thanks to everyone who has helped him during his service as Chair of the Board.

6. Message from the Ministers

Rev. Marion Davis referenced the individual reports from Rev. Dr. Kate Crawford and herself in the Annual Report on pages 6-8. She stated that it has been a year with challenges amid many, many joys. Rev. Marion reported that there is a great working relationship among the staff.

7. In Memoriam

Rev. Dr. Kate referenced page 16 in the Annual Report which lists Baptisms, Marriages and Funerals. The Funerals were performed by either herself, Rev. Marion, Rev. Florence Sanna or Scott Parsons. She read aloud the names of loved ones listed in Funerals as we remembered them prayerfully.

8. Reports of Groups and Committees

8.1. <u>Finance</u> (pg. 40-47): John Evans, Chair of Finance reported that it has been an absolutely great year and we should be proud of the work done. A deficit for Operations had been budgeted, but at the end of the year, we realized a surplus. Next year's budget still shows an operating loss because this year the increase in envelope givings is only 1%; we received many donations in memory of people who have passed away. John extended thanks to everyone for their great support; especially to the clergy who performed wonderfully, and rose to the challenge of coping with the reduction from 2 to 1 3/4 positions.

The year end statement shows a significant amount of cash because a major portion of the givings occurs in December; loan payments are due in January. Accessibility loan balance is \$19,000; Organ Loan balance is \$278,000 with part two involving some restoration and other deficit accumulation amounts to a further \$52,000. A loan of \$100,000 had been approved for this of which \$60,000 has been applied as above. The balance of the approved loan will be drawn on in the next few months to repair leaking windows. The Men's Club intends to help. There is a total debt of \$350,000 and payment plans to address this are in place.

Kate inquired about the Restoration Fund. Last year we collected \$39,000 in envelopes directed towards Restoration; on the direction of the Board, \$25,000 was put towards facility repairs and the remainder was applied to the Organ Loan. Plans to spend \$20,000 to repair the Towers are not in the budget, but are covered by Restoration and the Men's Club.

8.2. Organ Refurbishment Committee (pg. 26 - 27): Dave Norris sent his regrets. Dave Roberts referenced the report which outlines details and figures. In August 2007, the organ was dismantled and shipped to Quebec for restoration and returned to Gower in the spring, 2008; in October 2008 it was rededicated. As of December 2009 we are halfway towards paying off the loan since the launch of the campaign in November 2007.

FINANCE COMMITTEE REPORT

The Finance Committee would like to express a sincere 'Thanks' to everyone in helping to meet our 2010 financial objectives, whether through donations or by exercising cost control measures.

We finished the year with a small operating deficit of about \$2,000 while making over \$60,000 in payments on the interest and principal on our organ loan, contributing a province leading \$44,000 to M&S and reducing the balance on two other loans.

This past year the Men's Club undertook the financing of the \$20,000 restoration which the Property Committee did to the north church towers. By year end they had \$10,000 of this repaid and repaid an additional \$5,000 early in 2011. Their continued support is very valuable and much appreciated.

The ladies continued their strong support of our operating fund with an \$8,000 donation.

As we enter 2011 we have the following outstanding loans:

Accessibility \$5,200 Organ \$228,000 Other Loan \$46,000

Additionally, the Property Committee has indicated that facility restoration (from leaks, etc.) will cost in excess of \$150,000.

We have applied for a small Heritage Grant and are attempting to 'top-up' the 'Other Loan', which was initially approved for \$100,000, to make a start on this much needed work,

Unfortunately, as our congregation ages our offerings directed towards our day-to-day operations continue to decline. This is a source of concern, and we are pleased to see stewardship take on the challenge to address this in 2011.

Again, many thanks, and we look forward to your continued support in 2011.
