

# OFFICIAL BOARD ANNUAL REPORT

What an exciting year we have had at Gower. Following the Search Committee's work we called the Rev. Guy Matthews to minister to us and he began his ministry with us on July 1<sup>st.</sup> To fulfill his contract the Ministry and Personnel Committee hired Keith Wiseman to assist the Rev. Guy with the pastoral care needs of the congregation. His ministry with us as a Congregational Designated Minister has worked well, the Pastoral Care committee has recruited new members and visiting is more coordinated. We were sorry to lose the Rev. Marion Davis at the end of June and wished her well in her retirement and her future whatever it may hold for her.

After twenty-six years work at Gower, David Noseworthy took up a new position with the Stella Burry Cando organization, helping to train people wishing to become janitors or custodians and he is training some of these students at Gower. In addition to cleaning and other janitorial work, the Cando students, under David's supervision, have painted, repaired water damage and carried out other maintenance projects. I am sure that you will agree the appearance of the interior of the building is much improved.

A number of fundraising events took place this year. Over a 120 people enjoyed an exciting Spirit of Newfoundland dinner and musical based on the ABBA story. This was organized by the Stewardship Committee who also sold cocoa and cookies at the Once Concerts held in the Sanctuary in December. The Once asked for donations to the Organ fund and during their concerts here raised almost three thousand dollars. The building is busy most days with our own organization meetings, outreach, and with rentals. The "Love of Learning" group now meets at Bridges to Hope and the Gym is rented to a music promotion group led by Carl Goulding. The Outreach Committee is organizing lunch for needy people every Wednesday and would be pleased to receive help, money or catering, with this project which is providing lunch for an increasing number of diners. With the increased number of rentals the Property Committee is looking for a volunteer to prepare the contracts for would-be renters and coordinate the use of the building by outside organizations while ensuring our own groups have adequate space.

Gower is so fortunate in having many dedicated volunteers to carry out the tasks that need to be done. In addition to work of the Pastoral Care, Stewardship, Outreach, and Ministry and Personnel Committees mentioned already, the Property Committee is on call 24/7 if emergencies occur and is to be congratulated on the repair to the Memorial Hall roof, the furnace, and many other jobs that were carried out during the year. The Worship and Sacraments Committee also has a heavy workload as they oversee the Worship Services, the Sanctuary and its use, and keep the Official Roll and oversee baptisms and the use of the Sanctuary for marriages and other events. The Finance Committee meets regularly to administer Gower finances and to ensure that we are on a sound financial footing while the Trustees watch over our endowments and capital assets. The Christian Education Committee supervises the education and encouragement of our children which is a very important part of our Christian mission. The Heritage and Archives Committee has been busy looking after historical documents and memorabilia from the past. Currently they are looking into ways for Gower and the United Churches of the North East to join together to celebrate two centuries of Christian Service started by our Methodist forebears. The Men's Club, the United Church Women, and those organizing and providing for the Senior's Club meetings provide outreach and social opportunities for their own groups and the congregation. The men take on responsibility for various building restoration projects and the U.C.W. have donated significant amounts of money over the years to the Mission and Service Fund, the Gower Operating Fund and other charitable organizations. The dedication of the Choir and Gower Community Band and service to Gower is exemplary. We are most fortunate.

I have not counted the number of those volunteering but know it is legion. It is also important that we recruit new volunteers to fill in for those taking a break, moving away, or taking on different responsibilities. As we heard during a recent sermon, like the disciples so long ago we need to hear Jesus' call to follow him and do his work. Work that has changed in many ways with the passing of time but is still requires us to answer His Call.

The Finance Committee presented a balanced operating fund account for 2011. The Board gives all who donated to the operating and other fund accounts a big thank you because you make Gower's mission possible.

Finally, thank you to all our staff: our ministers, office staff and office volunteers, the Cando employees, and our musicians for their dedication and effort.

In your name I ask it,



## REPORT FROM THE MINISTER

### **REV. GUY MATTHEWS**

"I thank my God every time I remember you, constantly praying with joy in every one of my prayers for all of you, because of your sharing in the gospel from the first day until now." – Philippians 1:3



These words of Paul to the young church in Philippi express the pride and joy that he feels to be a part of their church community. I can identify somewhat with that. I am so proud to have been called to be your minister and I take great joy from how my family and I have been warmly received into the Gower faith community.

The Philippians' church was well known for its faithfulness in the practical sharing of the gospel message. Gower has a magnificent history of witness and service that in 2015 will have

encompassed two hundred years. It has played a vital role in the history of the city of St. John's and in the lives of generations of people.

This church community that Paul is addressing is facing the challenges of its day – membership struggles, the scarcity of financial means to support itself, a changing political landscape, a society often indifferent and sometimes even openly hostile to its mission and message, the struggle to be relevant, and so on. Amazingly, and sadly too, these same challenges are with us today in Gower and throughout the Church.

However, like the church at Philippi, Gower continues forward - driven by the faith of its members, the wisdom and dedication of its lay leadership and a strong sense of community.

I have had the privilege to serve among you for just seven months. Even in that short time I have come to understand somewhat the pride that you feel as members and the sense of purpose under which you live, work and worship. There has been much for me to learn about Gower's rich history in order to understand what so many of you already know and embody.

There continues to be the challenges of an aging congregation, limited financial resources, a high maintenance property, and a changing role in the greater community. Yet, Gower's is a history of engaging and embracing change. Over its history it has just not merely survived but has remained vital and relevant to members and to the world.

I want to thank all of you for the opportunity to minister with you. I am grateful for all who attend worship and encourage those who do not to please come out and join us. I stand in awe of the many who volunteer in roles both large and small, out front or behind the scenes: Board and committees; groups for men, women children and seniors; choirs and bands; studies, Sunday School and Christian education; outreach and pastoral care; worship participation; ushering and office volunteers; and everyone who serves.

I am grateful for Linda, Keith, Doug, Carl, and Edsel whose roles as full and part time staff are so faithfully fulfilled and who make it such a joy for me to minister among you.



# GENERAL PROTESTANT CEMETERY COMMITTEE



The General Protestant Cemetery Committee has experienced a successful year, having operated both cemeteries and still having a small credit balance at year end. This means that the funds collected for burials was sufficient to cover off the operation and maintenance of both cemeteries.

The Cemetery Committee had quite a busy year in 2011 making arrangements to prepare for the opening of the new cemetery known as "Memorial Gardens" in the Southlands area. Several meetings were held between Government and the General Protestant and Roman Catholic Committees in respect to building a road to the cemetery. The Government essentially agreed to do so and the road was completed last fall. Our committee has now signed a contract with S and H Codner to prepare ten acres of land in the new cemetery, once cleared, this area will be a parking lot with an area seeded and grassed over. This is scheduled to take place this spring. In 2011 a Columbarium was also established in Mount Pleasant for cremations. The Committee will have to obtain a loan in order to have the new cemetery ready for use this fall.

The flower services were quite successful in 2011 with a small increase in donations at Mount Pleasant. In the coming year the flower services will be held at Mount Pleasant on July 9 and at the General Protestant on July 23. (Dates will be confirmed later)

The Committee wishes to thank Gower St. United Church for its contribution in 2011 and hopes to receive another contribution in 2012.

# REPORT FROM YOUR EAST DISTRICT REPRESENTATIVE



On June 3-5, 2011, I attended the East District Spring Meeting at Burry Heights Camp and Retreat Center. The special guest speaker was Sister Elizabeth Davis, Congregation Leader, of the Sisters of Mercy in Newfoundland and Labrador. She spoke on the theme "WHERE TO FROM HERE? She helped members of the Court to look at the signs of things emerging in our midst and to look at ourselves. Sister Davis said that all churches should maintain their roots and traditions, but accept the fact that as a result of the new social media trends in all denominations we must change our ways of doing things.

Along with the E.D. committee reports at the Spring Meeting Dr. Lawrence Dewolfe gave a report from the Atlantic School of Theology and showed a promotional video for AST. The Atlantic School of Theology is doing well and is excited about the programs they are offering both on campus and online. This year they had the largest graduating class in a number of years and there is a growing need for Educational Supervisors and Learning Sites. On a different theme, Rev. There was considerable debate and discussion among the guest speakers and delegates regarding social change in the United Church of Canada. In the Fall we were honored to have Mardi Tindal, Moderator of the United Church of Canada as our special guest. She brought warm greetings from General Council and she participated in a panel discussion around the theme of our meetings.

I find the meetings very educational and inspirational. The Chairs of the various Committees and our special guest speakers should be applauded for their hard work and dedication in the work of the United Church of Canada. The social aspects of the meetings are fun and uplifting. Before the sessions we have a Gathering with Music with the delegates singing their favorite hymns and playing musical instruments. The delegates are treated to a delicious dinner at the Milestones in Ministry Banquet that is held on Saturday nights during both the Spring and Fall Meetings.

The meetings conclude with the "Celebration of Ministries" inspired by beautiful music that is provided by various churches of the East District.

I am pleased and proud to say that many people in the congregation stepped forward resulting in Marion's last few months being made easier as a result. Thanks to everyone!

Throughout the spring the M&P Committee worked to smooth the way for the arrival of our new Minister and at the same time to bid adieu to Rev. Marion. As you may recall we had a wonderful event for Rev. Marion and I know she was truly grateful for all the heartfelt wishes from everyone. There is no doubt we are a better congregation having being blessed with Marion's guidance and leadership during her time with us.

It was just prior to the arrival of Rev. Guy when we learned of the departure of David Noseworthy after 28 years as our custodian. David left to take up a position with Stella Burry Foundation working with one of their projects – Can-Do Enterprises. Even though Dave left he was certainly not out of the picture. When we subsequently signed a contract with Can-Do to provide custodial and maintenance services, David became associated with the Team responsible for our building. We all had the opportunity in September to say farewell to him and to pay tribute to his many years of service to our church.

The JNAC report that had been prepared in 2010 recommended that we call one full time Minister plus a permanent part time person to focus on Pastoral Care. Once the Call was issued to Rev. Guy we then proceeded to satisfy this recommendation. Consequently, we developed a Designated Congregational Minister position and undertook a staffing process. The result of which was the hiring of Mr. Keith Wiseman as a Designated Congregational Minister. I know you will all agree that Keith has been a wonderful addition to the ministry of Gower.

Once again throughout the year our regular staff continually went beyond the call of duty to ensure that things went as smoothly as possible. The Choir under the Leadership of Dr. Doug Dunsmore and Organist Carl Goulding continued to provide inspiration to us all. The Gower Community Band also continued to provide the opportunity for the musically inclined members of our congregation and the community at large to perform and contribute to services during the year. The band under Edsel Bonnell continues to provide an outreach service to the entire City. During our discussions with all three it was quite evident that they each continue to derive great joy from the roles they play in the life of Gower Street.

Our Office Manager Linda Hogan continues to be the anchor in the office that keeps everything on track. Linda has had a very busy year. In addition to "breaking in" a new Minister, taking on the role as the onsite liaison with Stella Burry; filling in as Editor of the Newsletter; and managing the increased activity related to Rentals she does manage to do her regular work!!!! ## **WORSHIP & SACRAMENTS**

### Mandate

The mandate of the Worship & Sacraments Committee includes providing for regular and special worship services, the administration of the sacraments, developing policy with respect to the admission, transfer and removal of membership. The Committee has the responsibility to recruit, train and organize people to assist the clergy at the service of Holy Communion, support the clergy in the organization and conduct of Baptism, and recruit and organize greeters and ushers for all services. The Committee also has the responsibility to advise the clergy and Board on the use of the church sanctuary.

## **Change of Ministry/Worship Services**

Inspirational and well-planned Services of Worship were conducted regularly throughout the year. In June 2011 we said farewell to Rev. Marion Davis who had provided faithful leadership and spiritual guidance to our congregation for 6 years. In July we welcomed our new clergy-Rev. Guy Matthews who brings enthusiasm and a deep commitment to the life and work of our congregation. A Covenanting Service was held in November to honor this relationship. We also welcomed Keith Wiseman as a Congregational Designated Minister to support Pastoral Care in our congregation.

Music continues to be an important part of worship at Gower, and we wish to thank Doug Dunsmore, Carl Goulding, Dana Collins, Edsel Bonnell and the members of the Senior and Children's choirs and the members of the Gower Community Band for their commitment and their gifts of time and talent directed to the enrichment of worship through music.

#### **Sacraments**

- Holy Communion was celebrated six times throughout the year.
- Nineteen children and one adult were baptized

To welcome newly baptized members to our congregation, the Church sends a letter of welcome and anticipation of the upcoming baptism and delivers the Certificate of Baptism to the homes whenever possible, following the baptism.

## **Membership**

- Confirmation classes were held in conjunction with other downtown churches with five members of our congregation received as members of the congregation in June.
- Our thanks to Pat West who kept the Membership list up-to-date until this Fall, and to Judy Byrne who volunteered to continue this task.

#### **Funerals**

There were 26 funerals conducted by the Gower clergy.

## PASTORAL CARE REPORT



The Pastoral Care Committee consists of 12 members and the Pastoral Care Visitation Team consists of 17 persons from the Congregation and the committee.

Since September 2011 the committee:

- Has met monthly
- In addition to the visits made by Reverend Matthews, 138 visits have been made to members.
  - 57 of these visits were made by Visitation Team and 81visits by Keith Wiseman. Each visitation is approximately 30-45 minutes in length. These included ongoing visits to those celebrating 50<sup>th</sup> Anniversaries & beyond as well as those celebrating 90<sup>th</sup> birthdays & beyond.
- Organized, assembled and delivered Christmas Baskets to Shut-ins 52 persons.
   Thanks and appreciation to the Committee members who prepared the baskets and those who helped deliver them.
- Consulted with Reverend Florence Sanna & Reverend Scott Parsons regarding training for the visitation team to be held in the Spring 2012.

# **CHRISTIAN EDUCATION COMMITTEE**



### **Committee Membership:**

In February 2011, Karen Tuck stepped down as Chair of the committee after serving in this role for six years. We wish to express our sincere thanks to Karen for her years of devoted service on the CE Committee, as well as for her ongoing involvement with the Sunday School program.

The Committee membership is currently:

Carolyn Anstey-Moore (Chair) Kelly Hudson-Lewis Sue Wilton Dana Collins The CE Committee held monthly meetings in the Church Office on the first Wednesday of each month during the year, with discussion focussed on the committee's work, in particular in the areas of youth ministry and the Sunday School program.

## **Update on Sunday School Program:**

Regular Sunday School classes were held during the first three Sundays of each month; while the fourth Sunday of the month was typically reserved for junior congregation, where all the Sunday School children came together to share in worship. A total of 14 children ranging from 3 to 9 years of age are currently registered in the Sunday School program, and are divided into two classes, including five (5) children in the Pre-Kindergarten to Gr. 1 class, and nine (9) children in the Gr. 2 to Gr. 6 class. Based on the low number of children > Gr. 6, it was decided to drop the regular class for this age group this year, and instead offer special youth sessions throughout the year to this age group. Eight (8) members of the congregation have volunteered as teachers, with six teachers split among the two classes with a teaching commitment of one Sunday per month, and two teachers (Kelly Hudson-Lewis and Carolyn Anstey-Moore) responsible for junior congregation and special sessions. The Season's of the Spirit curriculum was used as teaching material for all age groups, and follows the revised common lectionary year.

In addition to attending regular Sunday School classes, the children participated in many special events this past year. In March 2011, the Sunday School children took part in a special four week lesson focusing on the Lord's Prayer lead by Kelly Hudson-Lewis. During this four-week session the children learned not only the words, but the meaning of the Lord's Prayer through movement, art, music, cooking, and meditation. On Palm Sunday, the children prepared their own miniature Lenten Gardens, as part of a special Stations of the Cross worship.

The Sunday School program finished on June 19, 2011 with a farewell party. Junior Congregation, for ages 3 and up, was held throughout the summer months.

On Sept. 11, 2011, the Sunday School program resumed with a welcome back party and registration. On October 1, 2011, the Fall Family gathering was held in Pippy Park, and many of the children and their families came to enjoy outside games, a nature scavenger hunt, and a delicious chilli dinner.

The year wrapped up with our annual White Gift Play held on December 4, 2011, and the Advent Clay Event, held on December 17, 2011, where the Advent season was celebrated by the Sunday School families through a simple meal, a Nativity craft to recreate Jesus' birth with clay, and a short worship service.

Over the past year, the Sunday School children have also participated in a number of worship services, including the Palm Sunday Service, a special youth-led worship service held on April 3, 2011, and the Hanging of the Greens Service held on November 27, 2011 to observe the beginning of the Advent Season.

In addition, most of the Sunday School children are also members of the junior choir, which was newly formed this year under the direction of Dana Collins. This past year, the junior choir

performed at a number of special worship services, including the Family Sunday, White Gift, and Christmas Eve services. Their contribution was much appreciated by the congregation.

We thank all the Sunday School teachers for their continued commitment and enthusiasm, as well as the parents and rest of the congregation for their support throughout the year. Also, many thanks to Susan Wilton for her continued dedicated work in organizing and maintaining a clean and safe church nursery, and to our many nursery volunteers for their support.

# **OUTREACH COMMITTEE**



The past year has been a positive one for the committee. We welcomed Jill Howlett as a new member and just recently Susan Green also joined us. We focus on being open to assisting members of our downtown community as best we can.

Donations to the Mission and Service Fund totaled \$39,834.60 in 2011. This included \$688.77 to World Development and Relief Fund which is a result of Birthday Money collected monthly. Our goal for 2011 was \$44,000.

The year began with an evening "Fun Fair" with over 75 members of ANC attending. The evening included games, fish pond, much socializing and of course food! Participation of Gower members had decreased over time, and we decided to re-direct our efforts towards those who live in the downtown. This led to the start of the Gower Street Lunch Program.

The lunch program has operated every Wednesday since the end of October, with volunteer support from Gower members as well as other congregations, businesses and individuals/families. All volunteers have expressed interest in returning to do another lunch. Lunch is open to anyone who wishes to attend, with 35 to 55 people served weekly. We eat together with our guests, and have learned much from conversation with them. Guests have been very positive about the program, and the opportunity to select some clothing or toiletry items to take home with them. Generous donations of over \$1600.00 have been received from individuals and companies to assist in the financing of these meals.

Patricia Mercer, an Outreach member, recently participated as a volunteer in the World Council of Churches Ecumenical Accompaniment Program in Israel/Palestine. Since her return she has been available to give presentations on her experiences to advocate for just peace through international law and an end to Israel's occupation of the West Bank and Gaza.

Selling beads from the Dorcas Widows of Uganda continued until the summer of 2011. We had been involved in this project for at least 4 years, and had satellite supporters especially on the Burin Peninsula. After selling over \$6000.00 in beads, we finally decided that our market was well-saturated and it was time to move on to another project. There are still a few beads in the church office if you are interested in getting some.

In June, newcomers to Gower were recognized at a reception after Sunday service in combination with the celebration of Confirmation. Each newcomer received a corsage/boutonniere to wear for the day.

During the fall, Outreach led Sunday worship while Rev. Guy was at district meetings. Support for this service was provided through East District, and focused on the work of Stella Burry.

During December, White Gift Sunday was well-supported by the congregation once again. Donations were delivered to Iris Kirby House, Naomi Center, Emmanuel House, For The Love Of Learning, and Street Reach. A gracious letter of thanks was received from Iris Kirby House, with verbal thanks from the other organizations.

Support for Bridges To Hope continued in 2011, with regular food donations of protein products, weekly volunteering at the food bank, and participation in the third Annual Community Fundraiser which allows Bridges To Hope to help meet the needs of the community in many ways: Toy Lending Library, expansion and improvement of the food pantry, Christmas food hampers, Passion for Projects, and a variety of educational programs through the Community Kitchen.

We always welcome new members. Please speak with any member of the committee.

Our additional activities during the past year were:

## GOWER BAND PROGRAM GOWER COMMUNITY BAND

The Gower Community Band continued its 38-year legacy of service to community through music as a non-denominational outreach program of Gower Street United Church with 15 performances during 2011. The main

focus was the GCB Seniors' Program with "concerts for people who can't get out to concerts" held at Karwood Retirement Centre, Masonic Park, the Veterans' Pavilion of the Miller Centre, Cambridge Estates, Glenbrook Lodge, Hoyles Home, and Escasoni. Church services included a Musical Sermon on the theme "A Beam in Darkness" at St. Paul's Anglican Church on March 6, and another on the theme "Sing a New Song" at Gower on June 5, in conjunction with the Gower Men's Club. The Band also presented its annual Palm Sunday Musicale at Gower on April 16, and the traditional Christmas Musicale on December 18, followed by the 25<sup>th</sup> GCB annual "Carols & Concert" at the Shrine Club. On May 27 the Band performed in the concourse of the Arts and Culture Centre at the final session of Memorial University's Spring Convocation, and on June 18 provided the music for the dedication ceremony of the Methodist College/Holloway School Memorial Park on Long's Hill.

The Band's commitment to music education was evident once again in its 2011 Terra Nova Gala Concert on October 30, when scholarships were presented to two promising young composers at MUN Music, and their works premiered in concert. Eleven creative new works have merited scholarships in the GCB Composition Competition during the past four years. In addition, the Band maintains the annual \$1000 entrance scholarship at MUN Music honouring the service of the Gower Youth Band, as well as internal scholarship funds for Band members, training programs, master classes, and workshops. Through the generous continuing support of Mrs. Trudy M. Green in memory of her beloved husband, Jack, the Band has established the Jack Green Memorial Fund to support its scholarship and community development programs.

The GCB continues to attract new members, especially musicians moving to St. John's to work or study at MUN, and the vibrant intergenerational musical family ranges in age from 11 to 78. A new volunteer executive team headed by General Manager David Robbins is expanding the committee structure to meet the diverse needs of the growing program and to undertake exciting new initiatives in music education and community service.

Finances: Income amounted to \$9,439.52, comprised of \$6,795 in donations, honoraria, and interest from the Gladys L. Roberts Memorial Scholarship Endowment; \$1,950 in revenue from concerts and sales, and \$694.52 in members' funds and bank interest. An additional gift in kind of instruments valued at \$1,000 was added to the Instrument and Equipment inventory (capital assets) but is not included in current account income. Expenditure amounted to \$7,103.64, comprised of \$507.80 in Music, Equipment & Instrument Maintenance, \$2,554.99 in Performance Expenses, \$1,870 in Scholarships & Training (not including the \$1,000 GYB Scholarship endowment established in previous years and administered by Memorial University), \$2,009 in Operating Expenses, and \$161.85 in Bank Charges. The surplus of \$2,335.88 was added to the accumulated surplus of \$4,238.16 from 2007-2010 for a total operating reserve of \$6,574.04 to be brought forward to 2012. This will allow the Band to expand its commitment to community service and program support as well as increased scholarship and training initiatives. There were no capital expenditures from the GYB Legacy Instrument & Equipment Reserve Fund in 2011. We have been very fortunate in respect of our maintenance program commitment in recent years. Inevitably, major expenditures in older instruments and equipment replacement and new acquisition will be required in the near future.

**Appreciation:** For the first time in 38 years of preparing annual reports on behalf of the Gower bands, this year I ask readers' indulgence in permitting me to express some personal comments. On May 27 past, Memorial University awarded me an honorary doctor of laws degree, in large part for my role in the founding and development of the Gower Band program. I will never forget the emotions which swept over me when Anthea and I walked out in the concourse of the Arts and Culture Centre and heard the GCB playing the hymn song "Prayer from Youth" which I had written for the GYB in 1975. It was a total surprise, and I cannot adequately express the sense of gratitude I feel to my colleague, Associate Director Ron Collins, and the Band members for those wonderful moments, and to my colleague in Gower Church music, Dr. Doug Dunsmore, for arranging to have the Band at the Convocation.

In my address to Convocation, I said that "I share this honour today with the people of Gower Street United Church who caught the vision 38 years (and more than 900 performances!) ago of establishing a non-denominational community band program which would provide music education and instruments, scholarship support, and opportunities for community service to anyone with a commitment to the love of music and the joy of service — a truly remarkable gift to community by a church and its supporters and benefactors, and of course the more than 400 musicians who have participated in this program over the years and who continue to touch countless lives with music and community service at home and abroad."

A truly remarkable gift to community by a church.... indeed. As I have said in Annual Reports over the years, the ministry of service by the Gower Community Band would not be possible without the support of friends and benefactors at Gower and in the wider community. And as we enter our 39<sup>th</sup> year, I can only repeat again our annual expression of sincere thanks to the Ministers, Official Board, Ministry & Personnel Committee, staff and congregation of Gower Street United Church for the vision, support, commitment, and friendship which has created and maintained this unique gift to community. Thank you all!

# ORGAN RESTORATION FUND COMMITTEE



#### **AMENDED**

During 2011 we received cash donations of some \$49,934. These gifts, combined with the donations and tax recoveries of prior years result in total contributions of approximately \$360,000 since the campaign was launched in November of 2007. In addition, we currently have commitments totaling \$7,500 to be received during 2012. This brings the overall total of donations and commitments to date, to \$367,500.

Last year we reported that the organ had been damaged by water as a result of storm damage sustained to the Church in September 2010 through Hurricane Igor. While the organ was repaired at that time, it subsequently became apparent that the damage to the church building was such that significant additional repair work was necessary to fix serious leaks and avoid future damage to the instrument. This work necessitated the removal of the organ, to protect it, while the critical repairs to the building were undertaken. While it was disappointing to have the organ out of service during the fall of 2011, the good news is that the work was completed as planned; the organ was back in place, good as new and fully functioning in every respect by December. We are most appreciative of the ongoing dedication and adaptability of the Choir, the Band and our music team leadership: Douglas Dunsmore, Carl Goulding and Edsel Bonnell.

As of December 31, 2011, after meeting our interest obligations, the principal on the organ restoration loan had been reduced to \$211,956 (It is noted that donations totaling some \$9,000 received in December had not yet been paid on the loan by yearend). Also, it should be noted that the

fund also had an account receivable of some \$14,000 related to the recovery of HST incurred in relation to insured repair costs related to damage caused by Hurricane Igor. It is expected that these funds will be received February of 2012. Collection of this account receivable, coupled with the funds received late in December, will have the effect of bringing the organ restoration loan balance below \$200,000 early in 2012. At this point therefore, virtually 60% of the initial \$500,000 capital cost of the organ restoration project has been repaid.

Again we want to reiterate that in so many respects, our success to date is attributable to the ongoing support of the Gower Congregation. This comes to us both in the form of regular direct donations, special donations in memory of family and friends, as well as continuing support for, and attendance at, various functions and activities sponsored by; the Men's Club, the UCW, the Choir, and the Band, and of course the art exhibitions and sales by Carl Stevenson. It must be emphasized as well that our progress also reflects the support of the broader community – the various "friends of Gower"; the foundations, the charitable funds, various members of the music community, including a number of organizations and individuals highlighted over the last four years. In 2011, "The Once" again stood out as a glowing example by turning their December concerts at Gower into a gesture of financial support for the Organ Restoration Campaign. These gestures, individually and collectively continue to be so important and so greatly appreciated.

As we enter 2012, your Committee is contemplating a revitalized emphasis on the campaign - **A Drive to the Finish.** In this regard we plan to approach the congregation in the weeks and months ahead to seek renewed support as we push on to complete the job. Already, there are a number of events in the works for 2012: the Men's Club Salmon Dinner in March, a musical initiative by the Choir in the spring, a Band concert in September, a Carl Stevenson Art Exhibition in November and we expect "the Once" will be back again in December. 2012 promises to be another year of meaningful progress.

Unfortunately, very recently it became apparent that the repairs to the building undertaken in 2011 did not permanently rectify the recurring problem of leaks in the Church building. The organ again sustained water damage following a severe rain storm in mid February of 2012. While it is most troublesome to face the associated disruption again, we understand that the necessary repair work will be covered by insurance. We do expect however, that our ability to use the organ will be limited for a period, until the building can be properly fixed, and this will likely cause a delay in our plans for various organ related initiatives in the weeks and months ahead.

We express our sincerest appreciation to every individual, group and organization that has supported the Organ Restoration Campaign to this point.

As we continue the campaign in 2012, we invite and welcome your ongoing support to help us in our "drive to the finish".

## HERITAGE AND ARCHIVES



The Heritage and Archives Committee is mandated to preserve archival materials and artifacts of the church and, through a variety of means, to inform the congregation of Gower's heritage.

After the congregational dinner of January 15, 2011, the Chair of our Committee gave a presentation of early drawings and paintings of Gower and photographs of the later years. As well, selected recordings of the Gower choirs and the Gower Youth Band were presented.

The highlight of the year was the arrival of two portraits, of Rev. Richard Knight and his wife Mary (formerly Hosier of Bonavista). Rev. Knight of England came to Newfoundland in 1816 as a Methodist missionary. He spent 44 years in Newfoundland and the Maritimes. He was a prominent minister in his time. The portraits were passed down through the family over several

generations, ending in California under the care of Richard Gamble Knight, a great-great-grandson. After his death, his wife contacted Gower and offered the portraits to the church for safe keeping. Our Committee accepted them on behalf of the church. They were dedicated at Gower on October 23. The pictures are now available for viewing, and digital copies will soon be provided for prints up to the original size.

This year, as usual, we received a number of documents and memorabilia from congregational members. We are most grateful and continue to urge anyone who has any items with Gower connections – photographs, minutes, correspondence, newspaper clippings, etc. - to consider donating them to the Archives.

## PROPERTY COMMITTEE



The property committee has had a very busy year. With the help from members of the congregation we managed to work diligently with the insurance company to complete repairs caused by hurricane Igor. We finally started in mid June and the insurance company agreed to cover the damages incurred. The roof above the organ was repaired, Casavant removed the pipes and all relevant parts of the organ, and then the cavity which houses the pipes belonging to the organ was totally restored. The south wall above the organ was re-plastered and painted and also the Taite-Osmond room was plastered, painted and the windows were repaired.

In June the Basilica replaced their heating system and we purchased 16 of their radiators so we have replacements for radiators that are needed in various areas of the building.

We have received word that we have been unofficially approved for a heritage grant that will give us \$ 30,000 to get the roof adjoining the church and the Memorial Building replaced to prevent further water damage in these areas.

As many of you know, David Noseworthy our caretaker for 30 years resigned in June. Thanks to volunteers in the congregation we managed to keep the building clean and ready for Sunday services until September 1<sup>st</sup> when Stella Burry Community services took over the cleaning and custodial services, along with minor electrical, plumbing and carpentry work. Since Stella Burry started we have installed a hand rail in the band room stairway, refinished and painted windows and walls in the sanctuary, painted and repaired the choir room, along with other jobs through out the building.

In the fall of the year we removed 4 layers of shingles off the roof of the Memorial Building and made some repairs before the roof was re-shingled.

September of 2011 we entered into a long term rental contract with ETCETERA Productions, which has already proven to be very beneficial for the church. They wanted to renovate the old church office along with the gymnasium, for which we agreed to offset the rent for the repairs

that were completed. They replaced flooring in the old church office and plastered and painted the entire area including the gym.

Our rental income has almost doubled this year thanks to the time consuming efforts of Linda Hogan.

Many thanks to all committee members; Vernon Simmons, Peter Nell, Diane Hogan and welcome to our newest members, Robert Tipple, Mike Herrell and Wilson Hiscock.

# MEETINGS OF THE DOWNTOWN CHURCHES



A couple of years ago East District prompted the four downtown churches to get together to see if there were ways in which they could cooperate. East District was particularly concerned that increased operational costs, declining attendance of young people and high restoration and repair costs were impacting negatively on the mission of the four downtown churches. A few members of each congregation, the ministers and members of East District have been meeting for the past couple of years to investigate ways in which the churches can cooperate more closely for the betterment of each congregation. The people attending the downtown meetings have changed somewhat at each meeting and the Board chairs have also met over lunch several times. A whole range of possibilities have been considered from economies of scale in purchasing, to becoming a multipoint pastoral charge. ## RESOLUTION BY THE BOARD OF TRUSTEES OF GOWER STREET UNITED CHURCH FOR APPROVAL BY THE CONGREGATION

At the recent meeting of the Trustees it was Moved by Guy Taylor, and seconded by Richard Pike THAT the "Resolution re Deed of Trust" attached hereto as Appendix A be, and it is hereby approved by the Board of Trustees; AND THAT the Chairman of the Board of Trustees make arrangements to have the Resolution considered by the Official Board of Gower Street United Church. In adopting the Resolution, the Trustees took note that, assuming it is adopted by the Official Board; the Congregation of Gower Street United Church; and the East District of the Newfoundland and Labrador Conference; it will replace the Deed of Trust for the Manse Fund, and noted that this was being taken in accordance with the procedure specifically provided in the 1989 Manse Trust Deed.

The motion was carried unanimously.

## Appendix A:

#### Resolution re Deed of Trust

1. The attached Resolution is to be considered, first, by the Trustees of Gower Street United Church (hereinafter, "Gower Street"); and then, if approved, by the Board of Gower Street; and then, if approved, by the congregation of Gower Street, in a meeting duly convened for that purpose; and then, if approved, by the East District of the Newfoundland and Labrador Presbytery of the United Church of Canada.

#### Text of Resolution:

WHEREAS the United Church of Canada Act (Statutes of Newfoundland, 1926, c.3, as amended) provides, in Section 4 (a) that:

"All property, real and personal belonging to or held by any Board of Trustees or by individual Trustees, in trust for or to the use of any congregation of The Methodist Church shall from and after the coming into force of this Act be held, used and administered for the benefit of the same congregation as part of The United Church in the manner and upon the trusts and subject to the terms and provisions set forth in Schedule "B" to this Act, and all property, real and personal, thereafter acquired by or belonging to or held by any Board of Trustees or by individual Trustees in trust for or to the use of any congregation of The United Church shall be held, used and administered for the benefit of the said congregation as a part of The United Church upon the said trusts and subject to the said terms and provisions";

AND WHEREAS the Model Trusts Deed of the United Church of Canada (enacted by the said Statute), and the Congregational Board of Trustees Handbook, 2004, authorize the appointment of Trustees by a congregation, and set out their powers, duties and responsibilities;

AND WHEREAS the congregation of Gower Street United Church has from time to time been the beneficiary of bequests or other gifts of real and personal property, to be held in trust for its benefit; AND WHEREAS the Trustees, Board and Congregation of Gower Street United Church, with the approval of the East District of the Newfoundland and Labrador Conference of the United Church wish to adopt further measures to govern the Trustees of Gower Street United Church (hereinafter "the Gower Trustees") in the performance of their duties, the discharge of their responsibilities and the exercise of their powers.

### NOW THEREFORE BE IT RESOLVED THAT:

- 1. This Resolution is to be read with the relevant provisions of the laws of Newfoundland and Labrador, including The Trustee Act, The United Church of Canada Act, and The Model Trusts Deed. The statutory provisions and those of the Model Deed shall prevail in the event of any conflict between them and those created and conferred by this Resolution.
- 2. (i) The **Congregation** of Gower Street United Church, or its successor, shall from time to time appoint not less than three nor more than fifteen Trustees, in the manner prescribed by paragraph 9 of the Model Trusts Deed and paragraphs 20 to 31 of the Handbook.
  - (ii) The Gower Trustees shall be appointed for a term of five years, and they may be reappointed for a second or successive term. Any Gower Trustee whose term has expired shall continue to hold his or her office until a successor is **chosen**. The appointments of all Trustees who hold office as of the date that this Resolution becomes effective shall terminate when the Resolution comes into force. The Congregation, before that date, shall take the steps necessary to appoint Trustees and shall arrange that those first appointed shall serve individually for terms of between one and five years, in such a manner as to ensure that the term of one-fifth of all the Trustees shall terminate in each succeeding calendar year. For greater certainty, it is declared that those serving as Trustees at the time this Resolution comes into effect are eligible to be re-appointed by the Congregation. The Congregation, in appointing Trustees in the future, shall take account of the advice set out in paragraph 20 of the 2004 Handbook, that congregations "may wish to have among the members of the Board of Trustees expertise in such areas as insurance and investments".
- 3. The Trustees shall elect one of their members to be their Chair, to hold office for the lesser of three years or the balance of his or her five-year term. The Chair shall be eligible to be re-elected.
- 4. The Gower Trustees shall hold all property, real or personal, belonging to or forming part of the property held in trust by either the Gower Trustees or the Manse Board of Trustees as of the date this Resolution becomes effective.
- 5. The Gower Trustees shall be governed by the terms of any bequest or gift to Gower Street of any property, either real or personal, and shall deal with that property in accordance with the terms of the bequest or gift.
- 6. (i) Subject to the foregoing clause, the Trustees shall annually, within 90 days of the end of Gower Street's financial year, calculate or cause to be calculated the Income earned by the investments held in trust during that year. For the purposes of the calculation, "Income" shall mean monies earned as dividends or as interest and one-half of any amount of **the net** capital gains actually realized during that year. The Trustees shall, forthwith, transfer to the Board of Gower Street a sum equal to **100%** of the Income (including one-half of the **net** realized capital gains), to be used by the Board for the benefit of the Congregation. The balance of the realized **net** capital gains shall be added

to the principal of the funds held in trust.

(ii) For the purposes of this Resolution, the "net capital gains actually realized" shall be computed by deducting from the amount of net capital gains actually realized during that year an amount equal to the sum of any accumulated and previously unrecovered capital losses for the previous year or years. For greater certainty, it is declared that this calculation effects only the amount of the "net capital gains" to be included in calculating "Income" for any given year and further that monies earned as dividends or as interest during a given year shall be considered "Income" even if there are accumulated capital losses that have not been recovered.

# Gower Street United Church Minutes of the Annual Congregational Meeting

February 27, 2011 Lecture Hall, following morning service

## 1. Welcome and Opening Prayer

Rev. Marion Davis opened the meeting and led us with a prayer. About 80 members of the congregation were in attendance.

## 2. Appointment of the Chair and Secretary for the Meeting

Moved by Henry Andrews and seconded by Gar Fizzard that Pat West chair the meeting and Karen Butt act as secretary.

## 3. Adoption of Agenda

Moved by Geoff Peters and seconded by Mary Taylor Ash, that the Agenda as circulated be adopted. Approved.

## 4. Approval of Minutes

The minutes of the last Annual Congregational Meeting held February 28, 2010 were moved for acceptance by Carl Wright and seconded by Linda Hogan. Approved.

## 5. Message from the Chair of the Official Board

The Chair, Dr. Pat West referenced her report on pages 4-5 in the 2010 Annual Report. Rev. Marion Davis referenced her report and added that she neglected to acknowledge Lorne LeDrew and members of M&P for their tremendous support during the year along with staff members; Linda Hogan and David Noseworthy.

### 6. In Memoriam

Rev. Davis referenced Church Membership on page 13 in the Annual Report and noted that the 2<sup>nd</sup> list title had an error. The word "Infant" should be deleted. She then read aloud the names of loved ones listed in Funerals section and prayed for them and their families.

## 7. Reports of Groups and Committees

**7.1.** <u>Finance</u>: (see report) John Evans, Chair of Finance reported that it has been a good year. A simpler version of the auditor's statement and the Auditors' Report were available. On behalf of the Finance Committee, he thanked all staff and volunteers for working diligently and for their support. In particular the U.C.W. and Men's Club are relied upon for their financial contribution on an ongoing basis. The Men's Club has taken on the repair costs for the North Tower and is quickly paying off this expense. Last year we met our expenses. There were additional costs including loan payments and

about \$60,000 due to the Organ Restoration Fund. The numbers for 2011 are conservative. During the last 5 years collections have dropped, and although up to the end of January, we are on par with last year, there is a prediction of a slight decrease in offerings.

There is a one time expense in the budget to fund the search committee, but if we maintain last year's giving's, this expense will be covered. Stewardship has committed to try and make up a shortfall up to \$15,000 by publicizing P.A.R. Property has an estimate of approximately \$200,000 for various repairs to the building. The Board Executive, Finance and Stewardship are looking for ways to carry out this work which will be done on a priority basis.

John thanked Verne Somers for his work as Treasurer during the past 4 years and welcomed Andrew Orsborn, a recent C.A. graduate, to the position.

## Motion John Evans/Ken Butt

That the Financial Statements for the year 2010 be hereby approved. CARRIED

John referenced the budget for 2011. He reported that each year offerings drop off slightly, investments are about \$60,000 per year, and fundraising income has decreased slightly, however they hope to maintain operating expenses. There is a loan payment of \$10,000, but this account will be finished in August this year. Questions and discussion ensued.

That the Financial Budget for the year 2011 be hereby approved. CARRIED

**7.2.** Organ Restoration Committee (pg. 20): In David Norris' absence, John Evans reported that loan payments of \$62,000 are fixed, with an amount regularly applied to the principal and interest. Damage caused by Hurricane Igor meant that \$18,400 was used to make necessary organ repairs, however insurance will repay all but the \$5,000 deductible. There are more repairs to the building which will be covered by insurance. When we receive our insurance settlement, we can decrease the organ loan balance to \$230,000.

**7.3.** Trustees (p.7) Sheridan Parsons, Chair reported that after the market collapse we lost 9% of Market Value, this year we are down by less than 1%. A list of the individual investments is available now and, in future the list will be in the Trustees' report. Geoff Peters asked a question about the endowment fund to which Gower Street is entitled and Ed Roberts replied that there are legal documents that would describe the disbursement of funds and noted that there are limitations that would have implications for the church should it fold or move. Pat West thanked the Trustees for their work.

## FINANCE COMMITTEE

Financially 2011 was a much better year than we had forecast at Gower, thanks to the help of all committees, especially Property, we were able to end the year very close to a break even position. [The number is slightly negative from an Operating perspective when one considers that \$4000.00 of the Rental Income was provided as an 'in-kind' contribution to Building Restoration].

Our collections continue to drop on a year over year basis. While in 2011 this drop was only about 3%; this gradual decline is a source of concern for your Finance Committee as with a facility this old our expenses will continue to climb. The Property Committee was able to obtain significantly greater Rental Income this year, with good prospects for continuing into the future, which is very encouraging. The income from rentals in 2011 almost doubled.

During the year we were able to borrow \$40,000.00 which was put towards the restoration of the Memorial Building roof. Late in the year we learned, unofficially, that our efforts to secure a Heritage Grant, on reasonable terms, would likely be successful early in 2012. If this is the case we should receive a further \$30,000.00 to put toward restoring the roof over the Sunday School/Nursery area; a project which has reached the critical stage.

Also during the year our insurers made repairs to the south end of the church which was damaged late in 2010 by Hurricane Igor. Because of the need to remove the organ pipes to permit repair the cost to the insurers was over \$250,000.00. [A storm early in 2012 showed that these repairs were not adequate; an item currently being followed up with the Insurers.]

As your Property Committee advised the Board during the year this beautiful, but aging facility, is in constant need of restoration and provided the Board with a list of projects totaling about \$200,000.00, of which the two roof projects mentioned above represented less than one third of the total. With the current debt for the Organ of \$211,000.00 and another loan of about \$76,000.00 we will have to approach this work as funds become available or with some creative thinking as without some form of guarantee further bank bowering is not possible.

Finally my THANX and appreciation to the Treasurer and other members of the Finance Committee and most importantly to you the Gower congregation for continued support during the year.
